The European Commission launched the Covenant of Mayors in 2008 to endorse and support the efforts deployed by local authorities in the implementation of sustainable energy and climate policies.

The Covenant and Mayors for Climate and Energy is a bottom-up movement that brings together municipalities of all sizes which voluntarily commit to implement EU climate and energy objectives through an integrated approach to climate change mitigation and adaptation.

**TO THIS END WE COMMIT, WITHIN OUR TERRITORY AND/OR AREAS OF EXPERTISE, TO:**


- **Promote** the Covenant of Mayors initiative, mobilising existing and potential signatories

## ANNEX – COVENANT SUPPORTERS' ACTIVITIES

Covenant Supporters are required to report regularly on their activities using an online questionnaire. This annex provides examples of activities they may carry out, according to their own areas of expertise and competence. It is to be used as a basis to complete the reporting questionnaire, to be sent at least every two years to the Covenant of Mayors Office.

### **Promote the Covenant of Mayors, mobilise existing and potential signatories**

- Inform members and other local authorities of the territory about the initiative, and encourage them to join
- Disseminate [Covenant promotional and/or technical materials](#), translate/adapt them to national or regional context or develop specific publications on the initiative
- Organise dedicated events (e.g. workshops, seminars, conferences), announce them on the [Covenant website](#), and help the Covenant of Mayors Office to identify events where the initiative could be promoted
- Leverage own communication tools (e.g. newsletter and blogs, publications, website, mailing lists, social media, etc.)
- Act as an intermediary between own members and the Covenant of Mayors Office, and with the regional or national media
- Trigger synergies amongst existing and potential signatories in their territory
- Other

### **Support and advise Covenant of Mayors signatories in your areas of expertise**

- Support the activities of own members and local authorities on sustainable energy and/or climate issues
- Help them mobilise financial support, inform them about potential financing sources
- Provide/develop technical guidelines or adapt the [existing ones](#) (e.g. SECAP Guidebook, Reporting Guidelines or other Reference Guides, [Urban Adaptation Support Tool](#))
- Organise technical, capacity-building events and working groups
- Inform own members and local authorities about potential synergies in the national, regional, and local context
- Provide information about European projects and help local authorities to get involved
- Other

### **Support experience and knowledge-sharing**

- Create experience-sharing opportunities amongst signatories (e.g. discussion forums, blogs)
- Include the Covenant of Mayors in the agenda of own events, working groups, committees, and other relevant fora

- Act as an intermediary between own members and other stakeholders with relevant expertise in the energy and/or climate fields
- Develop joint activities and collaborate with Supporters, Coordinators, and other key stakeholders in the territory and fields of expertise concerned
- Provide feedback on the implementation of own commitments on the territory
- Other
