PARTNERSHIP AGREEMENT BETWEEN

DIRECTORATE GENERAL FOR ENERGY OF THE EUROPEAN COMMISSION AND Administration of State Representative-Governor in Dusheti, Tianeti, Mtskheta, Kazbegi and Mtskheta city Municipalities (Mtskheta-Mtianeti Region)



Covenant of Mayors in Mtskheta-Mtianeti Region

THIS AGREEMENT IS MADE BETWEEN

The Directorate General for Energy of the European Commission (hereinafter DG ENER), at Rue de Mot 24, BE-1049 Brussels, Belgium represented by Klaus-Dieter Borchardt, Director for the Internal Energy Market, and the Administration of the State Representative-Governor in Dusheti, Tianeti, Mtskheta, Kazbegi and Mtskheta city Municipalities (hereinafter –ASRG Mtskheta-Mtianeti Region), at 7 Antioqia str., Mtskheta 3300, Georgia, represented by Nugzar Kipiani, State Representative-Governor.

WHEREAS

The European Commission launched the Covenant of Mayors in 2008 and the initiative is open to cities and municipalities of all sizes in Europe, with the aim of involving local authorities and citizens in the development and implementation of European Union energy policy. The Covenant consists of the commitment of the signatory cities to go beyond the EU objectives for reducing CO₂ emissions through energy efficiency measures, actions related to promoting renewable energy sources and sustainable urban mobility.

The European Commission recognises the entities acting as Covenant Territorial Coordinators as its main allies in conveying the message and increasing the impact of the Covenant. These Territorial Coordinators are defined as those public authorities that are in a position to provide strategic guidance and technical support to municipalities with the political will to sign up to the Covenant of Mayors, but lacking the skills and/or resources to meet its requirements, namely the preparation, adoption and implementation of the Sustainable Energy Action Plans.

ASRG Mtskheta-Mtianeti Region has among its main purposes the cooperation with municipalities in developing their policies and management programmes.



ASRG Mtskheta-Mtianeti Region considers that the Covenant of Mayors to be a very positive initiative; it is for that reason that it has decided to strengthen the promotion of the Covenant of Mayors among the municipalities of its area but also to reinforce its support to the municipalities who decide to formalise their commitment to the Covenant through a fruitful cooperation with all the other Covenant Coordinators operating within the territory of its competence. In order to achieve this, ASRG Mtskheta-Mtianeti Region is willing to launch a specific program to support local councils to attain accession to the Covenant of Mayors including, among other things, the preparation of Sustainable Energy Action Plans at Municipal level.

IT IS HEREBY AGREED AS FOLLOWS

DG ENER acknowledges that ASRG Mtskheta-Mtianeti Region is an important actor in the Covenant, in its quality as Covenant Territorial Coordinator for local authorities in Mtskheta-Mtianeti Region.

ASRG Mtskheta-Mtianeti Region is committed to carry out the following tasks, within the territory of its competence:

- a) Promote among the municipalities accession to the Covenant of Mayors.
- b) Provide financing to Signatories in the form of direct financial support (grants, subsidies, etc.) or via staff allocated to technical support for the preparation and the implementation of the Sustainable Energy Action Plans.
- c) Define the scope and methodology of the assessment, monitoring and verification reports, supporting the implementation of the Action Plans.
- d) Provide technical support for the organization of public events, for example Energy Days, to raise awareness about the Covenant.
- e) Report regularly to DG ENER of the European Commission on the results obtained in the Mtskheta-Mtianeti Region, and participate in discussions on the strategic implementation of the Covenant proposed by the Commission.
- f) Cooperate with all the other Covenant Coordinators involved in the Covenant of Mayors policies within the territory of its competence.



DG ENER in turn undertakes to:

- a) Provide visibility to initiatives taken by ASRG Mtskheta-Mtianeti Region (e.g. via the online profile, web news, benchmarks of excellence on the Covenant of Mayors website or via its promotional materials or events)
- b) Share and debate available information to make progress in achieving the common goals.
- c) Provide information on new developments in the Covenant process.

IV

This agreement does not imply any legal and/or budgetary commitment between the Commission and ASRG Mtskheta-Mtianeti Region.

This agreement shall be renewed automatically every year unless otherwise decided by either of the parties hereto.

The parties shall co-operate and work together on equal terms for their mutual benefit, towards the achievement of the objectives summarised herein. Should any provision or provisions of the present prove to be impracticable, the parties agree to prepare new alternatives for contributing to the aims of the Covenant.
